Presidential Decree No. PF-5308 adopted on January 22, 2018 [1], adopted on April 11, 2018 "Further reduction and simplification of licensing and permitting measures in the field of business activities, as well as measures to improve business conditions Presidential Decree No. PF-5409[2], adopted on March 7, 2019, "On measures to further strengthen guarantees of women's labor rights and support entrepreneurship" Presidential Decree No. PQ-4235 [3], Presidential Decree "On Measures to Fundamentally Improve the System of Support and Protection of Entrepreneurial Activities" adopted on May 14, 2019, "Entrepreneurial Initiatives in the Territories and Presidential Decree "On measures to organize rapid implementation of projects".

Uzbekistan paid special attention to the organization of business activities in the conditions of market relations. This required the organization and development of property relations, business activities, which are considered the legality of market relations. In fact, entrepreneurship is a mechanism that drives the economy of any society. For this reason, each country supports entrepreneurship based on its internal capabilities. Because private business activity is one of the important sectors of our country's economy and ensures social and economic stability. Therefore, it is envisaged that the state support of entrepreneurship in the Republic of Uzbekistan will be carried out in the following procedures:

- support from the state budget;
- at the expense of various funds and associations;

Therefore, it is necessary not only to provide preferential loans to those engaged in entrepreneurial activities, but also to form their passion for entrepreneurship. In order to support the population engaged in entrepreneurial activities by the state, retraining them for the profession is underway. As a result, there will be an opportunity to create new jobs. In order to implement this process, 700 million dollars were allocated in our country in 2019[8].
