Introduction

As stated in an address to the Supreme Court on the most important tasks of the development of our country in 2019 by president of the Republic of Uzbekistan Shavkat Mirziyoyev; "Our most important tasks are to reform the agricultural management system, develop advanced technologies for the rational use of land and water resurus, and ensure food security"

In a letter dawned December 30, 2020," "Centers for Knowledge Innovation in Agriculture will be established, providing more than 100 agro-services on the basis of a "foreign window". Through these centers, important services related to improving the quality of the earth, selecting breeders to fight diseases are provided.

Agriculture plays a vital role not only in supplying the consumer market with food, but also in the economy of our country. Therefore, since the first years of independence, much attention has been paid to increasing the production of agricultural products in our country. For example, a wide range of initiatives are being undertaken aimed at optimizing the content of crops, engaging in the production of modern technologies, and fundamentally improving breeding and selection work. Today's main requirement is not to increase the volume of agricultural products in exchange for expanding crops, but also to increase crop yields and livestock productivity.

During our analysis, the total amount of products (services) produced by rural, forest, and fish farms in Samarkand in 2019 will be \$30298.6 billion or 102.2 percent during the same period in 2018.

As our country's President Sh. Mirziyoyev pointed out, "The issues of reforming agriculture and ensuring food security will undoubtedly remain one of the most important tasks for us. Much attention will be paid to the consistent development of multi-network farms with the most avalo, aggression complex and its locomotive, or driving force."
