The education system in the Republic of Uzbekistan is legally regulated by the state and is under state control. In Article 41 of the Constitution of the Republic of Uzbekistan, the right to education and school activities are legally based on the main law of the state. That is, in Article 41 of the Constitution, "Everyone has the right to information." Free general education is guaranteed by the state. School affairs are under the control of the state." In our country, the state guarantees free education to its people under any conditions. If we look at the legislation on the education system, after independence, in 1997, the adoption of the "National Personnel Training Program" required the creation of legal foundations of the new education system. On August 29, 1997, the Law of the Republic of Uzbekistan "On Education" was adopted. This law also served as a basis for the development of education. The process of education and training that develops the national intellectual potential of the country is regulated by the above legal documents. Over time, a number of reforms were implemented in the rapidly developing society. The developing society, information communications, scientific development, world standards and foreign experience have clearly demonstrated the need for fundamental reform of the education system and the adoption of new laws and concepts. President Shavkat Mirziyoyev developed a number of programs to reform the education system.

In particular, in accordance with the decision of the President of the Republic of Uzbekistan No. PQ-289 dated June 21, 2022 "On measures to increase the quality of pedagogical education and further develop the activities of higher educational institutions that train pedagogic personnel" For students of the 2nd-4th grade who are studying in the form of full-time education in higher educational institutions, weekly training sessions are in the "4+2" order, including 4 days of classes at the higher educational institution, 2 days before school and in general The practice procedure was introduced in lim institutions. According to this decision, the "4+2" form of education was introduced in the 11th general education school of Andijan city. This form of teaching will be introduced as a new project for higher

education and school education in a short time, and will be enriched based on new methods in the future. First of all, this project provides an opportunity to conduct cooperation in the educational system - theory and practice in a timely manner. Development of a concept for the development of this method is important. **Second**, the "4+2" form of education serves to train national specialist teachers in the training of pedagogic personnel. Thirdly, it envisages the systematic development of higher education institutions and the improvement of management activities in them, the development of modern educational programs with the introduction of advanced foreign experiences. Fourthly, by raising the training of highly qualified professional personnel to a new level, this will allow students to work independently with their personal program, to create a plan for achieving didactic goals, to freely search for information sources, and to teach them the essence of freedom of education. gives an opportunity to understand. The improvement of the student's pedagogic skills, the spiritual feeling of pedagogy, appears in the school life of two days of the week. It also, encourages students' educational activity, helps to organize educational activities for acquiring pedagogical skills. In addition, this system of teaching for students provides continuous self-evaluation and encouragement of high-quality and rhythmic work, and for the school teacher, continuity. The "4+2" project places great responsibility on the school team. **Based** on the results of our further observations, we will express different opinions about this.

In conclusion, it can be said that the adoption of the law "On Education" in this form serves as an undoubted foundation for further improvement of the education system, training of qualified personnel and improvement of the quality of education.
