To do this, it is proposed to use according to the following scheme: A-condition; B-event; V-observer; G-cause; D-result, J-discussion.

RESULTS AND DISCUSSIONS

"Discussion №1: A) being(realism); B) rules for interpreting phenomena and using annotations; C) the realist philosopher, idealist, realist, materialist, religious, and atheist; g) the observer does not know, knows, and god knows; D)? C)?".

Discussion №2: A) the land of idealists, that is, the conditions in which any assumption is always confirmed; B) the rules for interpreting and using phenomena; V) idealist; g) The Observer does not know; D) any phenomenon can be used by interpreting it through approximately selected reasons.

Discussion \mathbb{N}_{2} : A) the land of materialists, that is, the conditions in which all objective reasons are stated in advance; B) the rules for isolating and using objects; V) materialist; g) the observer knows; D) What phenomenon should be used in isolation through factual objective reasons.

Don't say I haven't heard. In Uzbekistan, a transparent discussion has begun on the topic of how to interpret the phenomena of being and how to use the comments in being. Who is the blessing first? Idealist. Let this tell the abscess (materialist) that any phenomenon can be explained and used through approximately selected causes. Because there are objective reasons conditions that are not predictable. They can be used in practice after prior disclosure. Therefore, approximately We are obliged to use the chosen reasons extremely carefully, that is, to follow the idealists. Simply put, idealistic and materialistic blind and lame hunters in existence. Therefore, an idealist who has fallen into existence must go hunting, carrying the materialist on his shoulders. That is, a realist philosopher has to be idealistic in theory and materialist in practice.

If someone claims the next prophethood, God will have to selectively give his equivalent, which does not leave a place for any objection, by revealing that there is an unverifiable conclusion in the nature of the cause that knows.

Atheist. Well! If a double is asked to be a double in place, even in mosque and church is too "4", i.e. "Allah knows", not "the observer knows". An experimental confirmation of the subjective nature of the cause of "God knows" as an experience, of the absence of God in general, is a simple fact that this greatest fool also understands! Right?

Realist. Absolutely wrong! The fact is that a quarter table that no one knows is revealed through the reason for "God knows", and its subjective equivalent in existence is transferred to the discretion of the reason under "the servant knows".
