Introduction

This period is a period of radical improvement of the system based on the strategy of Actions¹ for the further development of the Republic of Uzbekistan directly on the initiative of the President of the Republic of Uzbekistan Sh.M. Mirziyoyev, every employee who provides timely and quality assistance to the population of the internal affairs bodies. It was a period of large-scale reforms aimed at turning "Serving the interests of the people" into a socially oriented professional structure that considers it a duty.

In 2016, for the first time in the 25-year history of independent Uzbekistan, the Law "On Internal Affairs Bodies" was adopted, which defined the main tasks, directions and principles of the activities of internal affairs bodies.

Main Part:

On September 16, 2016, in order to protect the rights, freedoms and legal interests of citizens, the property of individuals and legal entities, the constitutional system, ensure the rule of law, the security of the state, as well as prevent violations, by the President of the Republic of Uzbekistan Sh.M. Mirziyoyev The signed Law "On Internal Affairs Bodies" further strengthened the activity of this system from a legal point of view³.

This Law, which entered into force on March 17, 2017, is significant in that it serves to raise it to a new level, as it comprehensively regulates the status, forms and methods of the activities of internal affairs bodies⁴.

A solid legal framework has been created in order to transform the internal affairs bodies into a social structure that serves the interests of the people. In particular, 6 laws, 7 decrees and 40 decisions of the President, 89 decisions of the Cabinet of Ministers and more than 160 departmental normative legal documents were adopted⁵.

In particular, according to the decree of the President of the Republic of Uzbekistan No. PF-5005 of April 10, 2017⁶, analyzing the serious shortcomings and problems that have accumulated in the activities of the internal affairs bodies in recent years, their elimination, the most important way to reform the system of the internal affairs bodies complaints and for the first time in the history of our country, the procedure for the heads of internal affairs bodies to report on the performance of their duties before the parliament, deputies and the general public was determined. The decree also approved the "Comprehensive Measures Program for Fundamental Reform of the System of Internal Affairs Bodies".

By the decision of the President of the Republic of Uzbekistan on April 12, 2017, the regulation "On the Ministry of Internal Affairs" was approved⁷.

On the basis of the decree of the President of the Republic of Uzbekistan dated December 24, 2018 "On approval of samples of the flag and emblem of the Ministry of Internal Affairs of the Republic of Uzbekistan" No. PF-5602, the flag and emblem of the MIA was approved⁸;

- According to the decision of the President of the Republic of Uzbekistan dated April 12, 2017 "On organizational measures to further improve the activities of internal affairs bodies"⁹;
- By the decision of the President of the Republic of Uzbekistan dated April 18, 2017 "On measures to radically improve the activities of crime prevention units of the internal affairs bodies" No. PQ-2896, the number of existing prevention inspectors was optimized;
- Prevention by the decision of the President of the Republic of Uzbekistan dated April 20, 2017 No.
 PQ-2906. In the service areas attached to the inspectors, a system of personal cars allocation was established for them on the basis of service houses and preferential loans;
- Order of the President of the Republic of Uzbekistan dated April 18, 2017 "On measures to fundamentally improve the activity of internal affairs bodies in the field of crime investigation" No.

PQ-2898¹¹. By decision, a relatively new institution of investigation was introduced in the legal system of the Republic of Uzbekistan;

- In order to create additional facilities for the provision of passport services to the population, the order of the President of the Republic of Uzbekistan dated July 11, 2017 "Migration processes of internal affairs bodies and legalization of citizenship";
- In order to ensure full adaptation of the citizens deprived of their freedom to the society, in order to provide them with vocational training and employment With the decision PQ-3200 "On measures to radically improve the activities in the field of execution of punishments" ¹² the system of execution of punishment was fundamentally reformed and a production system was launched in them;
- Based on the requirements of the decision of the President of the Republic of Uzbekistan No. PQ-3413 of November 29, 2017 "On measures to fundamentally improve the procedure for working with personnel of internal affairs bodies and organizing their service", a completely new way of working with personnel system was introduced, "Disciplinary Charter" and "Internal Service Charter" of IIO were fully put into practice, social, moral and spiritual support of employees was systematized;
- In order to form a new model of public safety in Tashkent, the Presidential Decree of the Republic of Uzbekistan dated February 14, 2018 "On the implementation of a qualitatively new system of maintaining public order, crime prevention and fighting crime in Tashkent" With the decision No. 3528¹³, the activity of the internal affairs departments was launched on the scale of the capital, as well as the President of the Republic of Uzbekistan on June 19, 2018 "Effectiveness of ensuring public order, prevention of offenses and fighting crime in the city of Tashkent" According to the decision PQ-3786¹⁴ on additional measures to increase public order in the capital, there is a 3-shift, round-the-clock patrol service organized jointly with the iios, the National Guard and the public was put on;
- By the decision of the President of the Republic of Uzbekistan dated August 23, 2018 "On measures to introduce an effective system of management, control and work with personnel of internal affairs bodies" No. PQ-3919¹⁵, the single IIO Organizational units as a management system, as well as the Training Institute was established in order to train the reserve of management personnel;
- By the decision of the President of the Republic of Uzbekistan dated November 7, 2018 "On measures to radically improve the criminal-executive legislation" No. PQ-4006¹⁶ exit works were organized; the daily organization of crime prevention activities by local governors and the procedure

for monthly discussion of the work being carried out in this regard in the Council of People's Deputies is in accordance with the order of the President of the Republic of Uzbekistan dated December 24, 2018 "Additional measures to increase the effectiveness of public safety" It was launched based on the requirements of the decision PQ-4075¹⁷;

— The activities of the units for ensuring the safety of foreign tourists coming to our country at the objects of tourism and transport infrastructure are in accordance with the order of the President of the Republic of Uzbekistan dated March 6, 2019 "On the introduction of an effective system of ensuring public safety at the objects of transport and tourism" was further accelerated based on the requirements of the decision PQ-4229 "on additional measures".

Natijalar va muhokamalar (Results and Discussions):

Ensuring the rule of law in society, reliable protection of the rights and freedoms of the population, strengthening their satisfaction with life, confidence in the future, and the consistent implementation of efforts to guarantee a peaceful life are directly dependent on the work of the internal affairs system in many ways. For this purpose, on March 26, 2021, Presidential Decree No. PF-6196 "On measures to raise the quality of the activities of internal affairs bodies to a new level in the field of ensuring public safety and fighting crime" was adopted. done.

According to the decree, the problems related to the prevention of violations and the fight against crime in each neighborhood, family and individual are solved directly in the places themselves. Neighborhood law enforcement centers are established on the basis of the base points of the internal affairs bodies. Initially, neighborhood law enforcement centers will be established in the city of Tashkent in a model way. Until June 1, 2021, the "Smart neighborhood" information program will be launched in Tashkent and Samarkand regions, which will allow you to remotely send an application to the prevention inspector and monitor the process of its review. This information program will be launched in other regions of the republic by the end of 2021.

On January 10, 2019, at the meeting of the video selector chaired by the President of the Republic of Uzbekistan Sh. Mirziyoyev, the work in this regard was critically discussed, and the Ministry of Internal Affairs was asked to fundamentally improve the situation and eliminate existing shortcomings based on a thorough analysis. The task of developing "I map" was assigned ¹⁹.

In order to improve the effectiveness of crime prevention in places, special attention was paid to the field of working with unorganized youth and women. In addition, on the basis of the Law of the Republic of Uzbekistan dated September 2, 2019 "On Protection of Women from Harassment and Violence" 20, which provides state protection to women who have suffered from harassment and violence. The practice of issuing a "protection warrant" was introduced.
